

RULES AND REGULATIONS OAKRIDGE SALVADOR DALI CONTEST (THE “CONTEST”)

AGREEMENT:

These rules govern the Oakridge Centre Salvador Dali Contest (The “Contest”). The act of entering the Contest constitutes acceptance of the contest rules. By participating, entrants agree to be bound by the Official Rules which shall be final and binding in all respects.

ELIGIBILITY:

The Contest is open to all residents of British Columbia who have attained the age of 19, except employees of QuadReal Oakridge Centre Holdings Inc., QuadReal Property Group Limited Partnership, QuadReal Property Group G.P. Inc., bclMC Realty Corporation and their advertising, promotional agencies and/or contest sponsors, employees of Oakridge Centre retail and office tower tenants, and all of their immediate families. Contestant must have a valid Facebook and/or Instagram account to enter the social media contests.

CONTEST PERIOD:

The Contest runs from September 13, 2017 at 9:30AM PST to October 1, 2017 at 6:00PM PST (the “Contest Period”).

HOW TO ENTER:

1. Visit the Oakridge Salvador Dali Exhibit in the West Galleria
2. Post a photo of your favourite Salvador Dali art piece in the exhibit using the hashtag #definitelydali with @oakridgecentre and @chalirossoartgallery
3. Visit the Oakridge Centre Instagram page (@oakridgecentre) for winner announcements

No purchase is necessary. **Entry into the Trip to Paris contest has a limit of one per person.** Entries will be rejected if all required fields are not fully completed and submitted during the Contest Period. Oakridge Centre has the right to stop/cancel the event at anytime. Use of any automated system to enter is prohibited and will automatically result in disqualification. Winner will be randomly chosen from all collected entry submissions. Winner for the Trip to Florida will be announced no later than Friday, October 6, 2017. Winner of the trip to Florida must have a valid passport and have the ability to fly overseas.

PRIZE:

There is a total of one (1) GRAND PRIZE to be won during the Contest Period. The winner will receive two (2) round-trip economy class air tickets from Vancouver to St. Petersburg, Florida, Tour of The Dali Museum in Florida, plus 2-night hotel accommodation based on two (2) persons sharing one room care of Silkway Travel, Oakridge Centre. Prize valued at \$2,500 CAD.

All prizes must be accepted as awarded and are not redeemable for cash; taxes, fees and other charges are the responsibility of the winner.

PRIZE REDEMPTION:

GRAND PRIZE: The winning contestant will be contacted via social media private message no more than five (5) business days following the contest end date. All winners are chosen at random from a list of qualified entries. **To claim the PRIZE, the winner must visit Oakridge Centre Concierge within forty-eight (48) hours of being contacted.** The GRAND PRIZE trip to Florida must be arranged through Silkway Travel in Oakridge Centre using the awarded prize letter. Redemption of prize letter must be claimed before December 15, 2017 and valid for travel before March 31, 2017.

To claim the prize, the winner must show two (2) pieces of valid identification. In the event Oakridge Centre is unable to contact the winner, or does not receive confirmation from the winner within forty-eight (48) hours, the selected entry will be disqualified and an alternate winner will be selected from all remaining eligible entries. The winner must successfully complete the mathematical skill testing question and contest release form in person at Oakridge Centre before being deemed the official winner. Odds of winning a Prize depend on the total number of eligible entries received during the Contest Period.

Promotions are run in compliance with the Oakridge Centre *Privacy Policy*.

BANNING:

The sponsors may, in their sole discretion, prohibit any person from entering any contest that they believe to be abusing the contest rules. Such abuse includes entering false information. Oakridge Centre has the right to change, censor, remove, edit any content submitted. Any attempt to tamper with the entry process, interfere with these rules, deliberately damage any website or undermine the administration, security or legitimate operation of the Contest, is a violation of criminal and civil laws, and Oakridge Centre reserves the right to seek damages and/or other relief from all persons responsible for such acts to the fullest extent permitted by law, which may include banning or disqualifying entrants from this and future Oakridge Centre Contests. Use of any robotic, automatic, programmed or similar entry method or more than one entry during the Promotion Period will void all entries and result in disqualification. The act of entering the Contest constitutes acceptance of the contest rules and the decisions of the Contest judge.

All decisions of Oakridge Centre are final. Contests are governed by the laws of British Columbia and the laws of Canada applicable therein. Oakridge Centre and their parent, subsidiary, affiliated and related entities, and the officers, directors, employees, licensees and assignees reserve the right to cancel or modify any contest or the contest rules at any time without notice. Oakridge Centre and their parent, subsidiary, affiliated and related entities, and the officers, directors, employees, licensees and assignees reserve the right to substitute any prize or portion of the prize with a prize of equal or greater value.
